

ELSWICK PARISH COUNCIL

Minutes of the Ordinary Meeting held on

Thursday 22nd October 2009 in Elswick and District Village Hall commencing at 7.45 pm

1. APOLOGIES FOR ABSENCE – Cllr Taylor.

2. DECLARATION OF INTEREST – Cllr Emmington declared an interest in item 5(iii).
